Age Limit	:	Below the age of 70 years.
Salary/Perks	:	<ol style="list-style-type: none"> <li>1. Salary as per the recommendations of the 7<sup>th</sup> CPC for the post of Professor.</li> <li>2. A maximum of Rs. 4 lakhs per year shall be provided under the scheme as contingency allowance to meet the expenses towards organizing special lectures, conferences, attending seminars, workshops, meetings within the country, attending various meetings of Ministry of Steel and other infrastructure requirements, if any. These shall be on the production of proof of actual expenses and a part of reimbursable allowances.</li> <li>3. Incentive of up to Rs. 1 lakhs can be considered under the scheme for publishing research work in</li> </ol>

		international journals of repute (top 5 journals identified under the scheme) as well as attending international conference for presenting such research work within a maximum limit of five times in career span.
