Upgradation of Existing Assistant Professor Grade- II Pay Level- 10 (On Contract) to Assistant Professor Grade-II Pay Level-11 (On Contract)

As per Gazette notification dated 01-01-2024 regarding First Statutes of the National Institute of Technology (Amendment) Statutes 2023 of the MNIT Jaipur (the details are annexed), all clarifications issued from MoE on 13th September, 2017, 30th November, 2017, 4th December, 2017, 31st January, 2018, 20th April, 2018 and 16th April, 2019 are applicable in conjunction with qualifications and other terms and conditions of appointment of Academic Staff specified under Schedule 'E'. The candidates may note the following:

The Assistant Professor Grade–II appointed on contract basis in the Institute, on successful completion of one year of service in Level-10 of the Pay Matrix of the 7th Central Pay Commission, may be upgraded to Level-11 of the Pay Matrix of the 7th Central Pay Commission, if found suitable by a duly constituted Selection Committee. The following procedure shall be adopted:

- (a) The serving Assistant Professor Grade-II of the Institute who have completed one year of service in Pay Level-10 are required to apply online for upgradation to Pay Level-11.
- (b) Online application process will start from 10-01-2024. The last date of online application submission is 17-01-2024 till 5.00 PM.
- (c) Every completed online application shall be identified by a unique application reference number, which should be used in any future communication.
- (d) The duly completed application form along with the self-attested copies of relevant testimonials, certificates, enclosures etc. is to be sent to Dy. Registrar, Malaviya National Institute of Technology Jaipur, Jawahar Lal Nehru Marg, Jaipur 302017 by 18-01-2024, 5.00 PM failing which their candidature will not be considered. - (e) The Institute reserves the right to modify/ defer or cancel full / part of the notice / recruitment at any stage of processing.
- (f) The date for determining eligibility of candidates in every respect i.e. qualifications, experience, etc. shall be considered as on the closing date of submission of online application form.
- (g) Relevant category certificate should be submitted in the Government of India format.
- (h) OBC-NCL/EWS certificate should be issued on or after 1st April, 2023.
