If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
- 2. - 3. For EMD exemption, if firm doesn't claim under relevant category, his EMD exemption claim will no t be considered and the bid will be rejected. #### 7. Force Majeure

If at any time, during the continuance of this contract, the performance in whole or in part by either party of any obligations under this contract shall be prevented or delayed by reason of any war, or hostility, acts of the public enemy, civil commotion, sabotage, fires, floods, explosi ons quarantine restrictions, strikes, lockouts or act of God (herein after referred to as events) provided notice of happenings, of any such eventually is given by party either party to the oth er within 21 days from the date of occurrence thereof, neither party shall be reason of such e vent be entitled to terminate this contract nor shall either party have any such claim for dam ages against the other in respect of such non-performance, or relay in performance, and deliv eries under the contract shall be resumed as soon as practicable after such event may come to an end or cease to exist, and the decision of the Director MNIT Jaipur will be final and conclusive.

#### 8 **Arbitration**

- If a dispute of any kind whatsoever arises between the MNIT Jaipur and the bidd er in connection with, or arising out of, the Contract or the execution of the works or after their completion and whether before or after the repudiation or other termination of the contract, incl uding any disagreement by either party with any action, in action, opinion, instruction, determin ation, certificate or valuation of the Engineer, the matter in dispute shall be settled by arbitratio n in accordance with the Indian Arbitration and Conciliation Act, 1996 or any statutory amendm ent thereof.
- (b) The reference to arbitration may proceed notwithstanding that the works shall n ot then be or be alleged to be completed, provide always that the obligations of the MNIT Jaipur and the bidder shall not be altered by reason of the arbitration being conducted during the progr ess of the works. Neither party shall be entitled to suspend the works, payments to the bidder s hall be continued to be made as provided by the contract.

## 9. <u>Cancellation / Postponement of Programme</u>

- 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

This Bid is governed by the <u>सामान्य नियम और शर्तै/General Terms and Conditions</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition
