Terms and conditions governing the engagement of Medical Officer and Specialist Doctors on Part Time Basis at MNIT Dispensary Jaipur.

1. The engagement is purely on part time basis for a period of one year, with effect from the date of joining. The period of engagement can be further extended for next two years (on yearly basis) based on performance. The engagement can be terminated at any time (on either side) by giving one month's notice without assigning any reason.
2. The prescribed Qualifications/Experience indicated are bare Minimum and mere possession of the same will not entitle the applicants to be allowed for interview. Applicants having higher qualification and/or experience shall be preferred. The applicants should, therefore, furnish details of all the higher qualifications and experience possessed in the relevant field, over and above the minimum qualifications prescribed along-with documentary evidence.
3. The individual shall perform the duties assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra / additional allowance will be admissible in case of such assignment.
4. The individual shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits/allowances available to the Government Servants, appointed on regular basis.
5. The Medical Officers engaged on a monthly basis in the Institute Dispensary shall be entitled to 08 (Eight) Casual Leaves (CL) and 02 (Two) Restricted Holidays (RH) in a calendar year on a pro-rata basis.
6. The Non-practicing allowance will not be admissible.
7. The individual will not be granted any claim or right for regular engagement to any post under MNIT Jaipur.
8. The individual is not entitled to any Travelling Allowance etc. for joining the engagement.
9. If any declaration given or information furnished by the candidate proves false or if he/she is found to have willfully suppressed any material, information, he/she will be liable for removal from engagement.
