Objective (EICT Academy-Phase II)

It aims to equip participants with the knowledge, analytical capabilities, and practical tools required to integrate sustainability into organizational decision-making, meet evolving reporting requirements, and create long-term value in a human-centric and sustainable Industry 5.0 ecosystem.
