If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility for purchase preference based on documentary evidence submitted in case of product bids, whereas in case of services the eligibility is automatically validated. . Successful Bidder to indicate Contract number and name of Seller entity in the transaction details field at the time of on-line transfer. Bidder has to upload scanned copy / proof of the Online Payment Transfer in place of PBG within 15 days of award of contract.

23. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. It may be noted that benefit of EMD exemption and purchase preference to MSME will be given only to the manufacturers for the respective goods and service providers for respective services. Any trader including authorized dealer of OEM / service provider submitting MSME certificate will not be considered under MSME category for this bid and these benefits will not be applicable to such firm.
2. 9. **Optional:** If required, the procurement committee may visit the manufacturing site or supplied sites (IITs/NITs, etc.) for the verification and authentication of the claimed technical specifications.
